Subject: Welcome to the 2018 Tandem PPO Network, effective January 1, 2018

Dear Provider:

I am writing to welcome your provider organization as a participant in Blue Shield of California's (Blue Shield's) new **Tandem PPO Network**. The network will be available to Blue Shield members who enroll in any of the Tandem PPO benefit plans that will become effective January 1, 2018.

Open enrollment for 2018 coverage is around the corner, and we want to ensure you know about the new Tandem PPO plans and that your organization has been chosen to participate in the Tandem PPO Network.

We also want to remind you of the importance of updating your provider record information in a timely manner with Blue Shield, so that we can tell members how to find and access your services.

#### About the new Tandem PPO plans

Blue Shield is offering the new 2018 Tandem PPO plans as part of our commitment to provide access to quality care at affordable prices to our benefit plan members.

#### Here are some quick facts about the new Tandem PPO plans:

- These plans may only be purchased directly from Blue Shield.
- Members who enroll in a Tandem PPO plan will have affordable premiums and may choose
  to see any Tandem PPO Network participating provider to receive in-network benefits for
  covered health care services.
- The new Tandem PPO Network is about half the size of our full PPO Network and participants are available statewide. In certain regions, these network providers are also part of a Blue Shield Accountable Care Organization (ACO).
- As a participating Tandem PPO Network provider, your organization will have access to
   Manifest MedEx, the largest statewide health information exchange in California. This means
   you will be able to access medical records and claims data for Tandem PPO plan members.
   Access to such information will help provide you with a more in-depth picture of your
   patient's health needs. In addition, we hope that access to the records will strengthen
   coordination of care opportunities between the Tandem PPO Network healthcare providers

and practitioners, and help members avoid unnecessary tests and services that may be redundant.

All the benefit plans which appear below may <u>only be purchased directly from Blue Shield</u>. They are "off-exchange" and are <u>not</u> available to be purchased through the Covered California marketplace.
